STANDARDS OF CONDUCT FOR FAITH CHRISTIAN SCHOOL STUDENTS (7TH—12TH GRADE STUDENTS)

Faith Christian School exists to develop and graduate authentic Christian leaders. As part of its basic philosophy of education, Faith Christian School seeks to provide and maintain an environment that will most effectively train and mold our students' physical, spiritual, emotional, academic, and social growth.

When students are admitted to Faith Christian School, they become identified with the school. The school may be judged by the kind of persons they are and by the way they conduct themselves. It is expected that their conduct will reflect favorably on them and on the school at all times.

All students must understand clearly that in order to maintain its high standards, Faith Christian School reserves the right to discipline, suspend, or expel a student who is guilty of misconduct whether occurring on or off campus, at a school sponsored event or not. If a student exhibits unproductive behavior, he/she will be held accountable.

Faith Christian School expects each student to maintain Christian standards of courtesy, kindness, morality, and honesty. The school further requires each student to refrain from profanity, indecent language, gambling, cheating, sexual immorality, stealing, the use of any type of tobacco, drugs, alcohol, and pornographic materials, and from participation in occult, unlawful, violent or destructive acts.

Students are expected to abide by these standards throughout their enrollment at Faith Christian School. This includes during and outside of school. Students found to be out of harmony with Faith Christian School's ideals of work and life may be asked to withdraw whenever the general welfare of the student body demands it.

It should be understood that this is a joint agreement between the school, the parent, and the student. It should be obvious to the parent that the school will enforce these standards to the best of its ability. It should also be obvious to the school that the parent enforces these standards while the student is associated with Faith Christian School during the school term and the summer.
